## INVITATION TO BID FOR *SUPPLY AND DELIVERY OF LIBRARY REFERENCES FOR ALL CAMPUSES*

*(Professional & General Education Books for the New Curriculum)*

1. The *Surigao State College of Technology*, through the *General Appropriations Act (GAA) 2020* intends to apply the sum of *One Million Six Hundred Nineteen Thousand Nine Hundred Seventy Four Pesos & 66/100 (P 1,619,974.66)* being the Approved Budget for the Contract (ABC) to payments under the contract for *SUPPLY AND DELIVERY OF LIBRARY REFERENCES FOR ALL CAMPUSES (Professional & General Education Books for the New Curriculum)*. Bids received in excess of the ABC shall be automatically rejected on bid opening.
2. The *Surigao State College of Technology* now invites bids for *SUPPLY AND DELIVERY OF LIBRARY REFERENCES FOR ALL CAMPUSES (Professional & General Education Books for the New Curriculum)*. Delivery of the Goods is required *30 calendar days*. Bidders should have completed, within *Three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidder.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from *Surigao State College of Technology, Narciso Street, Surigao City* and inspect the Bidding Documents at the address given below from *8:00 AM - 5:00 PM, Monday to Friday*.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 5,000.00**



It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of Surigao State College of Technology ([www.ssct.edu.ph](http://www.ssct.edu.ph)) provided that Bidders who are interested to participate shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The *Surigao State College of Technology* will hold a Pre-Bid Conference on **March 19, 2021, 2:00 PM at Learning Resource Center, SSCT Building**, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **April 6, 2021 @ 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **April 6, 2021 @ 2:01 P.M at the Learning Resource Center, SSCT, Surigao City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Surigao State College of Technology* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
